GENERAL SHOW RULES

1. Entries will only be processed if:
 - Entry forms are filled out correctly and have been sent in time by mail, email or fax.
 - All entry and stable fees are paid and credited to the FEQHA-account until three days after the entry deadline.
 - A copy of the AQHA Certificate of registration is enclosed.
 - A copy of the AQHA membership of the rider (Open, Amateur or Youth) is enclosed. New Membership cards can also be purchased at the showoffice.
 - A copy of the membership of the exhibitor and the horse owner at an FEQHA (e.g. DQHA, AIQH ...) member association is enclosed or can be purchased at the showoffice.
2. Competitor/Exhibitor agrees to comply with the rules and regulations as stated in the show announcement.
3. The promoter retains the right to change the announcement, to transfer (change date and/or location) the event, or under return of all fees to cancel the event, if special circumstances should require this.
4. The promoter is not responsible for late or lost entry forms.
5. The competitor has the sole responsibility for his start.
6. Each horse must be liability insured and free of an epidemic and must come out from a stable which is epidemical free. The horse must be as well vaccinated against influenza. The certificate of vaccination must be carried with and on insistance it has to be shown at the show office.

The district office Amberg-Sulzbach demands for all horses from outside of Germany, to deliver the health certifiactes the showoffice.

Foreign horses without health certificates may not be brought to Kreuth. The vet papers will be checked locally by the official veterinarian.

FEQHA EUROPEAN CHAMPIONSHIP RULES AND REGULATIONS.

1. Governing regulation

The European Championships (EC) shall be governed by the rules and regulations of the AQHA Official Handbook and the FEQHA European Championship Show Rules. In case of conflict between AQHA and FEQHA rules, the latter will prevail. All participants and horse owners agree to abide by such rules and regulations.

2. Eligibility

To participate to the European Championships the owner of the horse at least has to be resident in an European State. For the purpose of this regulations Europe is intended in its enlarged geographical meaning. FEQHA will allow exhibitors and owners from Israel to compete in the EC as well.

The exhibitor and the horse owner have to be member of an FEQHA (z.B. DQHA, AIQH ...) member association. If the country of residency does not offer such an association, the exhibitor and the horse owner have to become members of other affiliated associations of their choice. Each participant will be personally responsible for the residency statements provided to the EC organization on entry forms. Copy of the membership card to an FEQHA affiliate has to be attached to the entry form.

3. On-Site Check-In Information

Exhibitors are required to produce a copy of REGISTRATION CERTIFICATES to the EC Show secretary. All horses may be identified by an official FEQHA inspector and any horse not matching its Registration Certificate may be debarred from participation without recourse of any nature.

Upon entry, every exhibitor and owner and all other participants accept the facility and grounds, including, but not limited to, the arena, stalls and alleyways, where the show is being conducted on an "as is" basis and agree to be solely responsible for property damage or personal injury caused by third parties to the exhibitor, participant or owner, his/her property or staff, or caused by himself/herself, his/her participant horses, exhibitors, representatives, agents and employees occurring in conjunction with this show; and further agree to indemnify and hold FEQHA harmless from any and all such liability, whenever or however, arising, not caused by FEQHA's own negligence or that of FEQHA's representatives, agents or employees.

4. Health Requirements

Each horse must be liability insured, free of any epidemic disease and must come from a stable free of any epidemical disease. The horse must be as well vaccinated against influenza. The certificate of vaccination must accompany the horse and it has to be produced at the show office upon request.

5. Clipping and equipment

Applicable rules are those of the hosting country.

6. Doping Controls

By signing the entry form every exhibitor and respective horse owner agrees to a possible doping test of the horse. In the AQHA shows the AQHA doping-regulations are applied according to the AQHA Official Handbook. In the finals the doping regulations of the FN and FEI are also applied, which do not allow any foreign substance.

Before the beginning of the finals the EC committee, composed of 2 FEQHA officers together with the showmanager shall select classes and within them the places to be tested.

The doping tests should be done within the hosting country by an FEI approved laboratory.

7. Insurance and other Regulations

Each horse owner at assignment of entry, each companion and visitor when entering the show area agrees with the directives and Instructions of the organizer and agrees to the regulations of the AQHA Official Handbook and the European Championship Rules and Regulations. The organizer is entitled to modify the competition according to the AQHA Official Handbook, to reschedule the show or, upon repaying the fees, to cancel the show if deemed necessary under special circumstances.

There is no contractual relationship between the promoter on the one hand and the visitors, competitors, exhibitors and owners on the other hand. Liability for theft and injury of persons or animals is excluded. Especially participants are not assistants in the sense of § 278 and § 831 German Civil Code (BGB). Each horse owner and participant submits with depositing the entry form and each escort and visitor submits by entering the show ground, to the guidance of the promoter as well as to the rules and regulations of AQHA

8. Refunds

Presenting a vet certificate before the beginning of a show the show management can repay half of the entry fee. Cattle charge and office charge on principle will not be repaid. Fee for stalls is only repaid, if the reserved stall is rentable again.

9. European Champion Title Award

The European Champions in Youth, Amateur and Open Classes are awarded through finals, which are accessed through qualifications. These qualifications are held through 4 AQHA Shows (s/c) (hereafter referred to as "go-rounds") held at the same location during the time scheduled for the European Championships. In Halter Classes Working Cowhorse and Cutting no finals take place and the European Champions are awarded according to the numerical score calculated from the placings in all four shows. (see § 10 for calculation schedule)

In all Halter classes with less than three exhibitors in the first show there will be no European Champions. In Performance classes with less than five exhibitors in the first show, no finals will be held and no European Champion will be awarded. **To get into a final the horse-exhibitor combination has to start in all four shows and must not be disqualified under any judge.**



10. Scoring in the Go-rounds

In all events points are awarded according to the placings reached in the go-rounds (schedule of points of the AQHA-World Show).

12. All-Around Champion

In the Youth, Amateur and Open Classes for each show an All-Around Champion is awarded separately.

13. Judging of the finals.

A minimum of five (5) judges will judge all classes. Judges will score and place each class independently and will place through fifteen (15) places. Their individual score or placing cards will be given to the European Championship Show management for tabulation. The highest and lowest score or placing will be discarded and placing shall be determined by combining the remaining three scores or placings.

14. Tie Procedures for the finals.

a. Placed Events

In the finals, all ties will be broken by totaling all five judges' placings. If the ties then cannot be broken, it will be done by using the tie-breaker judge. Judge number 1 is the first tie-breaker; if judge number 1 did not place any of the tied horses, then judge number 2 becomes the tie-breaker judge; if judge number 2 did not place any of the tied horses, then judge number 3 is taken into account etc., until the judge is found who placed at least one of the tied horses. This judge's placing will be used to break the tie. This method, and only this method, is used to break all ties in placed events for both the go-round and finals. The order of the tie-judges will be fixed by the showmanagement and published to the exhibitors.

b. Timed Events

If there is a tie for the three first places, the tie will be run off until there is a winner. The other ties will be broken by the placing received in the go-round. If, by chance, the same horses were tied in the go-round and the ties were left unbroken, then the ties must be run off until the placing is decided.

In the case of electronic timer malfunction, re-runs may be required as directed by show management and their decision shall be final.

c. Scored Events

If there is a tie for the three first places, the tie will be worked off until there is a winner. All other ties will be broken by totaling all five judges' scores. If the horses are still tied, then ties will be broken by the tie-breaker judge. Judge number 1 is the first tie breaker. If judge number 1 scored the tied horses alike, then judge number 2 becomes the tie breaker. If judge number 2 scored the tied horses alike, then judge number 3 becomes the tie breaker and so on until a judge is found who did not score the tied horses alike.

If all five judges scored the tied horses alike, then the ties will be broken by the following method:

- In the case of a go-round, the ties will be left unbroken.
- In the case of finals, the ties will be broken by the placing received in the go-round. If, by chance, the same horses were tied in the go-round, and ties were left unbroken, then the ties must be worked off until there is a winner.

15. Cutting rules

- Each cutting class shall have a new bunch of cattle.
- The deadline for entries in cutting classes may differ from the deadline fixed by the showmanagement for other classes.
- Competitors who entered their nomination for the cutting class in time will be guaranteed to have fresh cows to cut; late entries may have to cut with a used bunch of cattle.
- Cattle that was used in cutting may be re-used in Working Cow classes.

This rules and regulations have been adopted by an FEQHA Meeting on August 19th, 2006 in Kreuth and where revised by Dr Sybille von der Schulenburg and Dr Paul Didier on August 29, 2007. The cutting rule has been added at the FEQHA in April 2008.
